

RHS Hockey Operational Plan Updated (Nov. 16 start)

The RHS Hockey Operational Plan was developed using the **(Updated)** Town of Riverview Arena guidelines, NBIAA guidelines and the HU- Planning a Safe Return to Hockey.

MANDATORY PUBLIC HEALTH RECOMMENDATIONS ARE IN PLACE:

- Physical distancing 2 meters (6ft) (1 meter – 2 seats in the stands)
- Mask is always to be worn by all who enter the building (only exception is participants when on the ice)
- Covid Verbal screening to be answered prior to anyone entering the building
- RHS team manager Margie Steeves and assistant coach Andrew Colpitts to act as supervisors to ensure safety measures are in place and to do verbal screening

Entering the building

Anyone entering the building will immediately sanitize their hands with the available hand sanitizer. After sanitizing their hands and completing the verbal screening:

- athletes can enter the rink and go directly to their dressing room and remain there until warmup. They will continue to wear a mask until they put on their helmet. · Players are required to bring their own water bottles labelled with their name.
- Referees will go directly to their own room masked and socially distance until game time
- Spectators/guardians will wear their masks and enter the arena, find a socially distanced spot in the stands. 2 spectators/guardians can attend the game at the Riverview Arena at this time.
- Coaches, managers, physiotherapists, timekeeper, statistician, music coordinator and videographers will all move to their proper locations while wearing masks and socially distancing.

The maximum number of people in the rink at once will be 99

40 players

80 spectators/guardians - 2 per player

4 refs

6 coaches (3 per bench)

2 managers (1 per team)

1 music coordinator

1 timekeeper

1 statistician

2 videographers (1 from each team) NBIAA rule for videoing of all warmups and games

2 Physio therapists (1 from each team)

Total 119 people

Players will arrive 30 min before warmup at 7:15 pm. Players will leave within 15 min after the game

Parents will start arriving at 8 pm and leave asap after the game

Games start at 8:15 pm

Riverview Arena Covid Plan UPDATED (Starts Nov. 16)

Each individual user group will be responsible to abide by the following procedures and guideline for each scheduled use of municipal ice surface. User groups are to follow their own governing bodies' operational plan.

1. The province of New Brunswick screening questionnaire process will be posed to every participant, coach, spectator regarding Covid-19 prior to entering the facility. If anyone answers yes to any of the questions in the questionnaire access will not be granted to enter the facility and should immediately follow the directions indicated on the questionnaire.
2. User groups will collect contact information for all players, coaches, spectators, and volunteers who are associated with each group booking to assist in any contact tracing. Each entrant of the facility shall register with name, ice surface, contact number and email to facilitate contact tracing should it be required by the health authorities.
3. Community face covering is required in all areas of the arena except for the participant on the ice surface. Social distancing of 2 meters must be maintained at all times while walking in the arena. While seated 1 meter social distancing is allowed in the stands.
4. Participants will be directed to all entrances and exits of the facility. Signage will direct participants to and from their designated ice surface to control flow of patrons.
5. User Groups will be permitted in the building 30 minutes prior to their ice time and must go straight to their dressing room and remain in the dressing room until the other user group is off the ice surface and in their dressing room before they come out for their ice time.
6. User Groups must exit the building 15 minutes after their session.
7. Participants must come to the facility dressed in most of their equipment and ready for their activity.
8. Dressing room showers will be closed for the season.
9. User groups are not permitted to store personal equipment on the premises.
10. User groups should sanitize equipment prior to and after their rental.
11. Participants must use their own water bottles – absolutely no sharing! Please fill at home.
12. Drinking fountains will not be available for use.
13. Food and drinks are prohibited in all areas of the arena.
14. Spectators/guardians will be limited to two per participant. Upon entering the facility, spectators/guardians must go directly to the arena stands and remain seated on the marked seating spots. It is assumed that two people sitting together are within the family bubble and you are asked to leave 2 seats between you and the next group to ensure 1 meter separation. Once ice time is over spectators/guardians will exit the arena and wait for their participant in the exit hallway or outside of the building. No waiting around the arena surface or dressing rooms to allow less restrictive flow for the next user group.
15. Spectators/guardians are not allowed to stand by the rink glass for viewing.
17. Entry and exit of the lower arena will be done only by the lower parking lot doors. Entry and exit of the upper arena will be done only by the upper doors on Biggs Drive.
19. No individual who is not accompanying a participant or who is not a coach or referee or volunteer will be allowed to enter the arena.
20. Any User group, spectators/guardians not following the rules will result in their user groups next ice time being suspended or forfeited for the season.
